I further agree that under no circumstances will Bardel's acceptance and or review of my Creative Materials interfere with or impede Bardel's ability to continue to carry out its regular business activities in any manner it chooses.

I represent and warrant that I have the right to submit the Creative Materials to Bardel and that the Creative Materials are wholly original and will not infringe on any patent, copyright or other proprietary rights of any Third Party. I agree to indemnify and hold Bardel harmless from and against any and all loss, cost, liability or expense (including without limitation court costs and reasonable fees of attorney's and other professionals) arising out of or resulting from any breach or claimed breach of any of the representations and warranties made by me in this letter and or from any claim that Bardel's possession and or review of Creative Materials infringes on any proprietary or other right of any Third Party.
